What is this product?

Type

UCITS investment fund in the form of an authorised unit trust.

Term

The Sub-Fund has no maturity date, however the Manager is entitled to terminate the Sub-Fund at any time.

Objectives

Investment objective The Sub-Fund's overall investment objective is to aim to maximise total return and provide capital preservation (i.e. prevent the loss of value of your investment) through investment in the US investment grade credit universe i.e. investment grade credit securities issued in US dollars.

To achieve the Sub-Fund's investment objective, the Sub-Fund will invest at least 70% of its Net Asset Value in a broadly diversified range of USD denominated investment grade credit securities, issued by the US Government (or any agent or instrumentality of the US Government or other US Government-related entities) or corporate issuers, which shall include corporate and sovereign issuers domiciled outside the US, including no more than 10% of the Sub-Fund's Net Asset Value in securities issued by issuers in Emerging Markets.

The Sub-Fund will, under normal market conditions, invest in the underlying assets of the US investment grade credit universe which includes, but is not limited to, US dollar denominated investment grade corporate bonds and noncorporate bonds such as sovereign, supranational and foreign agency debentures and US government and agency obligations; hybrid debt securities; securitised assets including Agency Mortgage Backed Securities ("Agency MBS"). Agency MBS are mortgage backed securities which are created by quasi-government agencies.

The Sub-Fund may use other financial derivative instruments including credit default swaps ("CDS"), CDS indices and interest rate futures for efficient portfolio management and investment purposes.

The majority of the Sub-Fund's Net Asset Value will be invested in fixed and/or floating rate credit securities which carry a long term rating by either Standard & Poor's or Moody's or Fitch of BBB- or Baa3 or higher at the time of purchase.

The Sub-Fund seeks to promote environmental and social characteristics in line with Article 8 of the Sustainable Finance Disclosures Regulation (SFDR) by virtue of the incorporation of environmental, social and governance ("ESG")- and sustainability risk-related factors into the Sub-Fund's investment and credit analysis process for potential and current portfolio investments on an ongoing basis. This includes examining issues related to governance, such as business ethics and the overall quality of corporate governance of the issuing company, and an issuer's impact on the environment and their level of investment to

improve that impact, the issuer's treatment of human capital and the social decency of their suppliers, products or services.

Share Class Benchmark The benchmark is Bloomberg US Credit Index Total Return.

Benchmark The Sub-Fund is actively managed, in reference to a benchmark. Many of the securities in the Sub-Fund may also be represented in the benchmark because the Investment Manager uses it as a basis for portfolio construction, but the Investment Manager has some discretion to deviate from the benchmark composition and risk characteristics within certain risk parameters. Examples of this are being aware of and constraining differences in sector, country or constituent weightings between Sub-Fund and benchmark. These constraints will vary over time and are subject to change. The Investment Manager does not target a specific tracking error for the Sub-Fund but historically, tracking errors have ranged from 1-4%. This is subject to change at all times.

Though the Sub-Fund may share some composition and risk characteristics with the Sub-Fund's benchmark, the Investment Manager's discretion may result in performance that differs from that of the Sub-Fund's benchmark.

Redemption and Dealing This Unit Class of the Sub-Fund may be redeemed on demand on any dealing day as detailed in the supplement. The price you pay or receive depends on the net asset value per unit on the dealing day when the unit is bought or sold.

Distribution Policy This Unit Class does not distribute dividends and any income and gains will be reinvested in the Unit's net asset value.

Intended retail investor

The Sub-Fund is intended for investors who wish to invest in US dollar-denominated investment grade bonds issued by corporates and US Government-related entities, who can bear loss in the short to medium term and have a medium to long term investment horizon, who plan to remain invested for at least 5 years. Investors should be prepared to take on the level of risk identified in the section, 'What are the risks and what could I get in return?' The Sub-Fund is designed to form part of a broadly diversified portfolio of investments, particularly for investors with little past experience of this type of investment.

What are the risks and what could I get in return?

Risks



The risk indicator assumes you keep the product for 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

Be aware of currency risk. In some circumstances, you may receive payments in a different currency, so the final return you will get may depend on the exchange rate between the two currencies, and whether the share class is hedged or unhedged.

Performance scenarios

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 USD is invested.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

The Sub-Fund is designed for investors with a with a medium to long-term investment horizon; you should be prepared to stay invested for at least 5 years. However, you can redeem your investment without penalty at any time during this period at the prevailing net asset value, or hold the investment longer. If you redeem at an early stage this will increase the risk of lower investment returns or a loss.
