## What is this product?

### Type

UCITS investment fund in the form of an authorised unit trust.

### Term

The Sub-Fund has no maturity date, however the Manager is entitled to terminate the Sub-Fund at any time.

### Objectives

**Investment objective** The Sub-Fund seeks to maximize total return by primarily investing in high yielding, sub-investment grade debt securities of issuers domiciled in or exercising a predominant part of their economic activities in the "Asia Pacific Region", which includes Hong Kong, India, South Korea, Malaysia, The People's Republic of China, The Philippines, Singapore, Taiwan, Thailand, Japan, Australia, New Zealand, Indonesia and Macau.

These investments will aim to provide (i) interest income (for example, coupon payments on fixed income securities such as high yield bonds) and (ii) potential additional return from capital gain. The Investment Manager seeks to identify and capture attractive opportunities in the fixed income universe through constant review and monitoring of global economy, market themes, risk sentiment and analysis of the fundamentals aspects of individual fixed income securities – including but not limited to country, currency and issuing entity.

To achieve the Sub-Fund's investment objective, the Sub-Fund will invest primarily in non-investment grade debt securities (i.e. bonds that are rated below BBB- by S&P or Fitch Ratings or Baa3 by Moody's) or bonds which are unrated; the bonds must also be rated above CCC+ by Standard & Poor's or equivalent by Moody's or another rating agency. Bonds may include fixed or floating rate bonds that are issued by governments, supranational entities, public or private companies in the Asia Pacific Region.

The Sub-Fund may also invest in: asset-backed bonds and mortgage backed bonds (i.e. a bond which is secured by a mortgage or by a group of mortgages) rated above BB+ by Standard & Poor's or equivalent by Moody's or other rating agency; convertible bonds, contingent convertible bonds and exchangeable bonds.

The Sub-Fund may use financial derivative instruments ("FDI") for efficient portfolio management (including hedging) purposes only. The Sub-Fund will not use FDI extensively for any purpose.

The Sub-Fund seeks to promote environmental and social characteristics in line with Article 8 of the Sustainable Finance Disclosures Regulation (SFDR) by virtue of the incorporation of environmental, social and governance ("ESG")- and sustainability risk-related factors into the Sub-Fund's investment and credit analysis process for potential and current portfolio investments on an ongoing basis. This includes examining issues related to governance, such as business ethics and the overall quality of corporate governance of the issuing company, and an issuer's

impact on the environment and their level of investment to improve that impact, the issuer's treatment of human capital and the social decency of their suppliers, products or services.

**Share Class Benchmark** The benchmark is JP Morgan Asia Credit Index (JACI) Non-Investment Grade Total Return.

**Benchmark** The Sub-Fund is actively managed, in reference to a benchmark. The Sub-Fund is seeking to deliver excess returns over the Sub-Fund's benchmark. The holdings may or may not be components of the benchmark and the Investment Manager has broad discretion to deviate entirely from the benchmark securities, weightings and risk characteristics. The degree to which the Sub-Fund resembles the composition and risk characteristics of the benchmark is not a specifically targeted outcome and could vary over time, and the Sub-Fund's performance may be meaningfully different from that of the Sub-Fund's benchmark.

**Redemption and Dealing** This Unit Class of the Sub-Fund may be redeemed on demand on any dealing day as detailed in the supplement. The price you pay or receive depends on the net asset value per unit on the dealing day when the unit is bought or sold.

**Distribution Policy** This Unit Class seeks to pay out stable distributions consisting of income, gains and, potentially, capital as set out in the prospectus and supplement of the Sub-Fund. Distributions from capital may amount to a re-payment out of your original investment. Over time this could lead to the reduction or complete exhaustion of your holdings in the Unit Class. You may elect to receive payments of, or reinvest, the distributions from your units.

### Intended retail investor

The Sub-Fund is intended for investors who wish to invest in high yield sub-investment grade debt securities of issuers in the Asia Pacific Region, who can bear loss in the short to medium term and have a medium to long term investment horizon, who plan to remain invested for at least 5 years. Investors should be prepared to take on the level of risk identified in the section, 'What are the risks and what could I get in return?' The Sub-Fund is designed to form part of a broadly diversified portfolio of investments, particularly for investors with little past experience of this type of investment.

## What are the risks and what could I get in return?

### Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

## Costs over time

## How long should I hold it and can I take money out early?

### Recommended holding period: 5 years

The Sub-Fund is designed for investors with a with a medium to long-term investment horizon; you should be prepared to stay invested for at least 5 years. However, you can redeem your investment without penalty at any time during this period at the prevailing net asset value, or hold the investment longer. If you redeem at an early stage this will increase the risk of lower investment returns or a loss.
