What is this product?

Type

UCITS investment fund in the form of an authorised unit trust.

Term

The Sub-Fund has no maturity date, however the Manager is entitled to terminate the Sub-Fund at any time.

Objectives

Investment objective The Sub-Fund seeks to maximize total return consisting of current income and capital appreciation by primarily investing in USD-denominated high yield debt securities.

To achieve the Sub-Fund's investment objective, the Sub-Fund will invest primarily in USD-denominated non-investment grade debt securities, including fixed or floating rate bonds, that are issued by governments, supranational entities, public or private companies domiciled in, or whose principal operations are in developed markets. In selecting securities, the Investment Manager combines a top-down (meaning a general assessment of the overall market environment) and bottom-up (meaning a more subjective approach, researching the individual issuers) investment philosophy, with a strong focus on a security's relative value.

Under normal circumstances, the Sub-Fund intends to invest primarily in non-investment grade bonds (i.e., assigned with a rating of below BBB- by Standard & Poor's or Fitch Ratings or below Baa3 by Moody's) or bonds which are unrated.

The Sub-Fund may also invest in mortgage backed bonds (i.e. a bond which is secured by a mortgage or by a group of mortgages), convertible bonds, exchangeable bonds and preferred stocks. The Sub-Fund uses forward foreign exchange contracts to manage and offset currency risk.

The Sub-Fund seeks to promote environmental and social characteristics in line with Article 8 of the Sustainable Finance Disclosures Regulation (SFDR) by virtue of the incorporation of environmental, social and governance ("ESG")- and sustainability risk-related factors into the Sub-Fund's investment and credit analysis process for potential and current portfolio investments on an ongoing basis. This includes identifying securities' issuer's potentially material ESG risk issues based on ESG factors, including (i) climate impact (in particular the issuer's initiatives to achieve carbon reduction objectives), (ii) issues related to the treatment of human capital (including but not limited to ESG controversies, human rights and diversity and inclusion), and (iii) governance practices (including effective management and board oversight, strong ethical standards and continuous business and strategy improvements), and evaluating how they are being managed towards a sustainable outcome.

Share Class Benchmark The benchmark is Bloomberg Barclays U.S. High Yield 2% Issuer Capped Index.

Benchmark The Sub-Fund is actively managed, in reference to a benchmark. Many of the securities in the Sub-Fund may also be represented in the benchmark because the Investment Manager uses it as a basis for portfolio construction, but the Investment Manager has some discretion to deviate from the benchmark composition and risk characteristics within certain risk parameters. Examples of this are being aware of and constraining differences in sector, country or constituent weightings between Sub-Fund and benchmark. These constraints will vary over time and are subject to change. The Investment Manager does not target a specific tracking error for the Sub-Fund but historically, tracking errors have ranged from 1-4%. This is subject to change at all times.

Though the Sub-Fund may share some composition and risk characteristics with the Sub-Fund's benchmark, the Investment Manager's discretion may result in performance that differs from that of the Sub-Fund's benchmark.

Redemption and Dealing This Unit Class of the Sub-Fund may be redeemed on demand on any dealing day as detailed in the supplement. The price you pay or receive depends on the net asset value per unit on the dealing day when the unit is bought or sold.

Distribution Policy This Unit Class seeks to pay out stable distributions consisting of income, gains and, potentially, capital as set out in the prospectus and supplement of the Sub-Fund. Distributions from capital may amount to a re-payment out of your original investment. Over time this could lead to the reduction or complete exhaustion of your holdings in the Unit Class. You may elect to receive payments of, or reinvest, the distributions from your units.

Intended retail investor

The Sub-Fund is intended for investors who wish to invest in USD-denominated high yield debt securities, who can bear loss in the short to medium term and have a medium to long term investment horizon, who plan to remain invested for at least 5 years. Investors should be prepared to take on the level of risk identified in the section, 'What are the risks and what could I get in return?' The Sub-Fund is designed to form part of a broadly diversified portfolio of investments, particularly for investors with little past experience of this type of investment.

What are the risks and what could I get in return?

Risks



The risk indicator assumes you keep the product for 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that

the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of PineBridge Investments Ireland Limited to pay you.

Be aware of currency risk. In some circumstances, you may receive payments in a different currency, so the final return you will get may depend on the exchange rate between the two currencies, and whether the share class is hedged or unhedged.

Performance scenarios

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

Unfavourable: this type of scenario occurred for an investment between August 2022 and April 2024.

Moderate: this type of scenario occurred for an investment between September 2016 and September 2021.

Favourable: this type of scenario occurred for an investment between July 2014 and July 2019.

What happens if PineBridge Investments Ireland Limited is unable to pay out?

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 GBP is invested.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

The Sub-Fund is designed for investors with a with a medium to long-term investment horizon; you should be prepared to stay invested for at least 5 years. However, you can redeem your investment without penalty at any time during this period at the prevailing net asset value, or hold the investment longer. If you redeem at an early stage this will increase the risk of lower investment returns or a loss.
