What is this product?

Type

UCITS investment fund in the form of an authorised unit trust.

Term

The Sub-Fund has no maturity date, however the Manager is entitled to terminate the Sub-Fund at any time.

Objectives

Investment objective The Sub-Fund seeks long-term capital appreciation (i.e. to grow the value of your investment over the long term) by identifying new and changing economic and investment trends and investing primarily in the "Asia Pacific Region", which includes Bangladesh, Hong Kong, India, Indonesia, South Korea, Malaysia, Pakistan, The People's Republic of China, The Philippines, Singapore, Sri Lanka, Taiwan, Thailand, Vietnam, Japan, Australia and New Zealand, by taking a forward [looking] view of fundamental economic and market conditions across the region. The Investment Manager selects assets for the Sub-Fund which best complement this forward looking view, while taking into consideration liquidity, costs, timing of execution, and relevant factors pertinent to efficient portfolio management. The specific security selection criteria is based on the attributes of the asset class, relative attractiveness of individual securities and issuers available in the market and market conditions.

The Sub-Fund has no restrictions as to the proportion of assets allocated to individual countries or geographical regions, companies of any particular market capitalisation in the Asia Pacific Region and may invest across a range of economic sectors.

The Sub-Fund may invest in developed markets and in "Emerging Markets" in the Asia Pacific Region. Emerging Markets include but are not limited to Bangladesh, India, Indonesia, South Korea, Malaysia, Pakistan, The People's Republic of China, The Philippines, Sri Lanka, Taiwan, Thailand and Vietnam.

The Sub-Fund will invest the majority of its assets in a broad range of equity (i.e. shares) and equity-related securities of companies in the Asia Pacific Region (i.e. companies whose assets, products or operations are in Asia) and debt securities of issuers in the Asia Pacific Region, including governments, their sub-divisions, or companies or banks.

The Sub-Fund will invest in fixed and / or floating rate debt securities of varying maturities. The Sub-Fund may only invest up to 30% of the Net Asset Value in below investment grade or unrated issues.

The Sub-Fund does not intend to invest more than 45% of its net asset value in other investment funds including real estate investment trusts ("REITS"). These investment funds must have investment objectives and policies that are consistent with those of the Sub-Fund. Investment in other funds is made to expose the Sub-Fund to types of investments not covered already.

The Sub-Fund may also use financial derivative instruments including swaps, futures and/or contracts for difference in order to indirectly obtain exposure to shares, bonds and the performance of financial indices. The value of any such investment in swaps or contracts for difference will not, in aggregate, exceed 20% of the Sub-Fund's net asset value. The Sub-Fund uses forward foreign exchange contracts to manage and offset currency risk.

Share Class Benchmark The benchmark is a blended index of 60% MSCI All Country Asia Pacific ex Japan Daily Total Return Net/40% JP Morgan Asia Credit Index (JACI) Composite Total Return.

Benchmark The Sub-Fund is actively managed, in reference to a benchmark. The benchmark is a performance target. The Sub-Fund seeks a return equivalent to the performance target over five year rolling period but the Sub-Fund's holdings and risk characteristics are not constrained by the benchmark.

Redemption and Dealing This Unit Class of the Sub-Fund may be redeemed on demand on any dealing day as detailed in the supplement. The price you pay or receive depends on the net asset value per unit on the dealing day when the unit is bought or sold.

Distribution Policy This Unit Class does not distribute dividends and any income and gains will be reinvested in the Unit's net asset value.

Intended retail investor

The Sub-Fund is intended for investors who wish to invest in the Asia Pacific Region, who can bear loss in the short to medium term and have a medium to long term investment horizon, who plan to remain invested for at least 5 years. Investors should be prepared to take on the level of risk identified in the section, 'What are the risks and what could I get in return?' The Sub-Fund is designed to form part of a broadly diversified portfolio of investments, particularly for investors with little past experience of this type of investment.

What are the risks and what could I get in return?

Risks



The risk indicator assumes you keep the product for 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that

the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of PineBridge Investments Ireland Limited to pay you.

Be aware of currency risk. In some circumstances, you may receive payments in a different currency, so the final return you will get may depend on the exchange rate between the two currencies, and whether the share class is hedged or unhedged.

Performance scenarios

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 USD is invested.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

The Sub-Fund is designed for investors with a with a medium to long-term investment horizon; you should be prepared to stay invested for at least 5 years. However, you can redeem your investment without penalty at any time during this period at the prevailing net asset value, or hold the investment longer. If you redeem at an early stage this will increase the risk of lower investment returns or a loss.
